Terms & Conditions, Privacy

I hereby apply to be a member of Goulburn Railway Tennis Club and agree to be bound by the Club's Constitution, By-Laws and Policies, as well as the By-Laws and Policies of Tennis NSW and Tennis Australia.

To assist us in the provision of products and services, we need to collect personal information about you. When you provide personal information, you agree that this will be used by Tennis NSW, Tennis Australia and other Australian Tennis Organisations under the terms of this statement, and the tennis privacy policy located at www.tennis.com.au/privacy, which contains information about how you may access and seek correction of your personal information or complain about a breach of your privacy, and how we will deal with that complaint. Tennis NSW, Tennis Australia and other Australian Tennis Organisations may disclose your personal information to other parties, including our related companies, other Australian Tennis Organisations, and third parties who provide us services. From time to time, these third parties may be located (and therefore your personal information may be disclosed) overseas, including to the USA and the Netherlands and as otherwise specified in the tennis privacy policy. Tennis NSW, Tennis Australia and other Australian Tennis Organisations may use and disclose your personal information for direct marketing purposes regarding the products and services you are signing up to receive, unless you opt-out (which you can do at any time in accordance with the tennis privacy policy)

Terms & Conditions

- Alcoholic / soft drink beverages are not permitted on the courts.
- One (1) member is required per court. Meaning, up to three (3) guests may accompany you to play on that particular court. If additional courts are required, and additional members are not present, then court hire rates will apply.
- You are not permitted to use the courts for Coaching or to collect monies through use of the courts. Membership will be terminated immediately if in breach.
- You shall be responsible for any personal items brought into the facility and shall remove them when you leave.
- No animals of any kind, except those serving the needs of the disabled, are permitted in the complex.
- You or outside vendors are not permitted to provide and/or sell goods and/or services at the Goulburn Railway Tennis Club, without prior approval from the Committee.
- Non-marking tennis shoes or sneakers are required. Players may be requested to change shoes, if incorrect footwear is being worn.
- You grant Goulburn Railway Tennis Club indemnity from and against all claims, demands, remedies, suits, injuries, damage, losses, costs, liabilities, actions, claims for compensation and the like in conjunction with injury, damage or accidental death through the members' neglect or default or the neglect or default of any other person in connection with the members' use of the facility.
- Goulburn Railway Tennis Club will not be responsible for any loss of or damage to any property whatsoever belonging to members.
- Early morning and late evening players need to be mindful of the local residents who live nearby. Try to keep loud conversation and outbursts on court to a minimum.

Membership Types / Fees

Membership period valid for July - June. If joining partway through the membership period and more than 3 months remaining, then a per month pro rata rate will be charged instead (for Adult or Family only). If less than 3 months remain (for any membership type), the membership expiry will be the end of the following period (ie member will receive up to 3 months membership at no cost).

*This pro rata rate does <u>not</u> apply to membership renewals.

Adult	\$ 60.00	Annual Single Membership for players 18 years and over. Member receives a key to the complex and has access to the courts all year round.
Family	\$ 100.00	Annual Membership for up to 2 adults and up to 4 juniors. Member(s) receive a key to the complex and have access to the courts all year round.
Junior	\$ 25.00	Annual Single Membership for players under 18 years of age. Member receives a key to the complex and has access to the courts all year round.
Twilight	\$ 25.00	Annual Single Membership. Any age. Member has access to courts Monday to Friday between 3pm - 7pm. School Term weekdays only. No key issued.
Lost Key	\$ 10.00	Any keys lost throughout the year will incur this fee. Where membership is not renewed, keys must be returned. There is no cost to the member when keys are returned.
